

Timeline

As per my detailed discussions by phone with program manager Bryan Croft, and previous discussions with program officer James Missen -- my timeline for this grant was thrown into chaos for several years. I will explain in detail: not long after being awarded this grant, my mother was diagnosed as having cancer. I lost my father to cancer in 2010, so this was extremely distressing. For YEARS she struggled valiantly, through radiation, chemo, surgeries included a double mastectomy and part of her intestines... and in 2019 -- she was pronounced "a survivor", and my family was grateful to have been granted more time with her BUT, during those years, I had to dedicate my life to her care, and ceased all musical activities for a period of time. I had to. I, a multi-award winning musician, had no other options but to put things aside... until I could return to them. I explained all this to James Missen, who was very empathetic and extensions were granted. By the time I was ready, able and available to proceed -- the COVID-19 global pandemic descended upon us. I had just barely returned to touring and was in the UK when the pandemic struck, and narrowly made it back to Canada. That was in Nov 2019. By Dec, we were all in a state of global emergency -- and for the next 2 and a half years -- all musical activities ceased. I had 2 gigs in 2020 (whereas in 2019 I performed over 200 time around the globe). There were no clubs even open to perform at during the pandemic, so how was I to mount a performance? Here we are now in 2022 finally able to look at executing this grant.

Date

I am hopeful that **Sat-Jun-25** will be the concert performance date at Supermarket, Toronto (see below). This is the date I am working towards.

Venue

My initial proposal was to have the performance at Lula Lounge – but since Feb 2022, I have performed at Toronto's Supermarket several times, and now have a strong relationship with their booking agent Sebastian Cook. We both would like this concert to appear on the Supermarket stage and has provided a venue agreement (ATTACHED) detailing what we've discussed to date. There are still many details to work out yet – but this form is due in 24 hours, so I have included what I know at this time.

Possible co-presentation with Toronto Jazz Fest

One of the biggest challenges with jazz concerts is getting to word out to lovers of this music. To that end I approached the Toronto Jazz Fest to see if they would be interested in coming on board as a media sponsor – to advertise this show to their mailing list, in exchange for logo placement on all marketing and being named as a media sponsor. They are still working on their own main stage fest programming, so will not turn to club programming for a bit.

Summary

This scenario is still a moving target, with much yet to be worked out given how many moving parts mounting a concert of this magnitude requires. To summarize what I'm working towards – (a) a Sat-Jun-25 performance date at Toronto's Supermarket, with the Jazz Festival on board as a media sponsor.

4 – Is there anything else you want to say about your project.

I just wanted to take a moment to acknowledge how vital such funding is one's abilities to present their own artistry. A performance of this scale would not happen without the support of the Canada Council. And after years of caring for my mother, and then more years of not being able to perform due to Covid – the opportunity to present my compositions for this ensemble, via this funding, is VITAL to my being and in many ways represents a rebirth as a large ensemble bandleader.
